Supplementary Planning Documents Public Participation

09/58 Additional Consultation on the Inspectors Larger Site Option for the North West Cambridge Action Plan

Six week consultation: 9th March to 20th April 2009

The Chairman said that the site would make provision for two new Colleges, new departments, and housing for university support staff. Cambridge City Council & South Cambridgeshire District Council were working together on the Action Plan. An extraordinary meeting of SCDC had approved the larger site. This was far too big and would threaten the village of Girton by reducing the green belt and creating more traffic. There were also drainage implications. Girton PC could comment on these when the planning application was received which would also give an opportunity to monitor exactly what was being proposed for this extended site.

In the meantime we should write a letter referring to our responses to previous consultations and note that these have not been taken into account.
