**10/48** To receive reports on open spaces:

1. TEC

Mr Thorpe gave a verbal report. Town End Close is now being used as a nature reserve. A management group has been newly formed by Susan Williams and a local expert Stephen Tomkins was on hand.

2. Wellbrook Way

No report was submitted.

3. Smithy Green

Mr Gordon gave a verbal report. He and Mr Thorpe will take charge. He noted that the posts had been placed round the perimeter of the Green, and that there are 10 spare posts available for later use.

4. Alice Hibbert-Ware

Mr Thorpe gave a verbal report. Research on a re-vamp was completed yet. Penny de Lacey who does a lot of the clearing commented on the old tarmac area within Alice Hibbert-Ware area. It should be developed as a low maintenance area where people can sit. It would be better to have a few shrubs but not those that will need lots of watering. The Ceanothus on Church Lane has never been trimmed. He will come up with 3 different schemes for the committee to either accept or reject.

5. Car Park and corner of entrance

No report was submitted, but it was noted that drainage must be reviewed

6. Footpaths

No report was submitted, but Cllr Bromwich will look at footpaths
