**10/38 Welcome by Committee Chairman**

Cllr Clift welcomed everyone to the meeting.

**10/41 Open Session for the Public**

Objections were received from two members of the public about the proposed extension at 24 High Street on the basis that it would reduce light to the living areas, and reduce solar gain to solar panels which produce hot water, and electricity at 26 High Street.

- SCDC has refused planning permission for the sign outside the Wellbrook Way offices.
- The removal of the caravans on land to the north east of Green Acre Farm, Oakington Road, Girton needs to be pursued with the enforcement officer at South Cambridgeshire District Council.
- The planning application for 8 Woodlands Park is still being shown as “pending” on the SCDC planning website. This appeared to be an error.
