11/133 Welcome by Committee Chairman

11/134 Apologies for absence No apologies for absence had been received.

11/135 Members' declarations of interest for items on agenda Cllr de Lacey declared a personal interest in item 11/139/2 and noted that he will have a prejudicial interest in one of the items on the agenda for the next Planning Committee Meeting.
