Guidance notes on completing Form 3 of the Annual Governance and Accountability Return 2024/25

1. Every smaller authority in England that either received gross income or incurred gross expenditure exceeding £25,000 **must** complete Form 3 of the Annual Governance and Accountability Return at the end of each financial year in accordance with *Proper Practices*.
2. **The Annual Governance and Accountability Return is made up of three parts, pages 3 to 6:**
 - The **Annual Internal Audit Report** **must** be completed by the authority's internal auditor.
 - **Sections 1 and 2** **must** be completed and approved by the authority.
 - **Section 3** is completed by the external auditor and will be returned to the authority.
3. The authority **must** approve Section 1, Annual Governance Statement, before approving Section 2, Accounting Statements, and both **must** be approved and published on the authority website/webpage **before 1 July 2025**.
4. An authority with either gross income or gross expenditure exceeding £25,000 or an authority with neither income nor expenditure exceeding £25,000, but which is unable to certify itself as exempt, or is requesting a limited assurance review, **must** return to the external auditor by email or post (not both) **no later than 30 June 2025**. Reminder letters will incur a charge of £40 +VAT:
 - the Annual Governance and Accountability Return Sections 1 and 2, together with
 - a bank reconciliation as at 31 March 2025
 - an explanation of any significant year on year variances in the accounting statements
 - notification of the commencement date of the period for the exercise of public rights
 - Annual Internal Audit Report 2024/25

Unless requested, do not send any additional documents to your external auditor. Your external auditor will ask for any additional documents needed.

Once the external auditor has completed the limited assurance review and is able to give an opinion, the Annual Governance and Accountability **Section 1, Section 2 and Section 3 – External Auditor Report and Certificate** will be returned to the authority by email or post.

Publication Requirements

Under the Accounts and Audit Regulations 2015, authorities must publish the following information on the authority website/webpage:

Before 1 July 2025 authorities **must** publish:

- Notice of the period for the exercise of public rights and a declaration that the accounting statements are as yet unaudited;
- **Section 1 - Annual Governance Statement 2024/25**, approved and signed, page 4
- **Section 2 - Accounting Statements 2024/25**, approved and signed, page 5

Not later than 30 September 2025 authorities **must** publish:

- Notice of conclusion of audit
- **Section 3 - External Auditor Report and Certificate**
- **Sections 1 and 2 of AGAR** including any amendments as a result of the limited assurance review. It is recommended as best practice, to avoid any potential confusion by local electors and interested parties, that you also publish the Annual Internal Audit Report, page 3.

The Annual Governance and Accountability Return constitutes the annual return referred to in the Accounts and Audit Regulations 2015. Throughout, the words 'external auditor' have the same meaning as the words 'local auditor' in the Accounts and Audit Regulations 2015.

Guidance notes on completing Form 3 of the Annual Governance and Accountability Return (AGAR) 2024/25

- The authority **must** comply with *Proper Practices* in completing Sections 1 and 2 of this AGAR. *Proper Practices* are found in the *Practitioners' Guide** which is updated from time to time and contains everything needed to prepare successfully for the financial year-end and the subsequent work by the external auditor.
- Make sure that the AGAR is complete (no highlighted boxes left empty) and is properly signed and dated. Any amendments must be approved by the authority and properly initialled.
- The authority **should** receive and note the Annual Internal Audit Report before approving the Annual Governance Statement and the accounts.
- Use the checklist provided below to review the AGAR for completeness before returning it to the external auditor by email or post (not both) no later than 30 June 2025.
- The Annual Governance Statement (Section 1) must be approved on the same day or before the Accounting Statements (Section 2) and evidenced by the agenda or minute references.

- The RFO is required to commence the public rights period as soon as practical after the date of the AGAR approval.
- You must inform your external auditor about any change of Clerk, Responsible Financial Officer or Chair, and provide relevant authority owned generic email addresses and telephone numbers.**
- Make sure that the copy of the bank reconciliation to be sent to your external auditor with the AGAR covers all the bank accounts. If the authority holds any short-term investments, note their value on the bank reconciliation. The external auditor must be able to agree the bank reconciliation to Box 8 on the accounting statements (**Section 2, page 5**). An explanation **must** be provided of any difference between Box 7 and Box 8. More help on bank reconciliation is available in the *Practitioners' Guide**.
- Explain fully significant variances in the accounting statements on **page 5**. Do not just send a copy of the detailed accounting records instead of this explanation. The external auditor wants to know that you understand the reasons for all variances. Include complete numerical and narrative analysis to support the full variance.
- If the bank reconciliation is incomplete or variances not **fully** explained then additional costs may be incurred.
- Make sure that the accounting statements add up and that the balance carried forward from the previous year (Box 7 of 2024) equals the balance brought forward in the current year (Box 1 of 2025).
- The Responsible Financial Officer (RFO), on behalf of the authority, **must** set the commencement date for the exercise of public rights of 30 consecutive working days which **must** include the first ten working days of July.
- The authority **must** publish on the authority website/webpage the information required by Regulation 15 (2), Accounts and Audit Regulations 2015, including the period for the exercise of public rights and the name and address of the external auditor **before 1 July 2025**.

Explanation of Variances

Box 2: Precept or Rates and Levies

Eddington is a new residential community area built to support the key workers of the University of Cambridge. part of Eddington falls under Girton Parish Council. As a result of the significant increase in the population of Eddington, due to the completion of the building of new homes, the tax base increased by 283.6. This has led to an increase in precept compared to 23/24. This is despite a modest increase of £3.73 in a band D house.

Box 6: All Other Payments

A Parish Ranger has been appointed as a regular contractor. Girton Parish Council have approved and interviewed for this role as an employee going forward. This is expected to take place in July 2025. The increase in Other Payments relates to the increased maintenance and repair spend incurred by Girton Parish Council, including maintenance on the pavilion, recreational and green spaces through the village. There has been an increased focus on improving local community areas including Wellbrook Way green spaces (recently approved for GPC ownership by HMRC Land Registry), which were significantly overgrown and the Bowling Green. Maintenance of all Parish Council assets rather than the Recreation Ground only were new scopes of work that. Some with significant backlog that the Parish Council has undertaken this year. Other key spend areas include the funding of the Local Nature Recovery group working throughout the village and the work of our project managers, who have been working on resident requirements and data collection to support those requirements, to ensure the Parish Council is servicing the needs and desires of the local residents. The whole theme of the year has been delivering maintenance and continuous improvement. We would expect the work of our Project Planners to be brought forward for Planning approval during 2025_2026, the work to take their plans to RIBA Stage 3 was approved in January 2025.

Box 7: Explanation for High Reserves

As per the last three year's AGAR for Girton Parish Council, General Reserves remain high due to the planning and initiation off a Pavilion Refurbishment project. This project is now well underway and has during 2024/2025 our Project Manager, Wilby & Burnett have had over 33 requirement interviews with village organisations and stakeholders approved by the Parish Council. They have also attended our 2024 Village Feast and attended our Annual Parish Meetings in 2024/2025.

Having collected significant data and referred to a number of experts such as Cambridgeshire Cricket Association, Cambridge Football Association we are expecting three drawings to take to review by our approved stakeholders and community members at our Village Feast in July 2025.

Girton Parish Council approved the stage of work to take their plans for Girton Recreation Ground to RIBA Stage 3 in January 2025. This would lead to the spend of the Pavilion Refurbishment Fund which has been held as an ear-marked reserve for a number of years by GPC.

General Reserves held by Girton Parish Council as of 31st March 2025 were £515,113 from £548,618 held as of 31st March 2024. A reduction of £33,505 since last year. Money has been taken from this reserve for work by our Project Manager so we can keep as much money for the build as possible.

There is currently £50k in specified reserves for the Local Highways Initiative with Cambridgeshire County Council and £5k has been transferred to supplement our Play Equipment Reserve. We have purchased Scribe Software to allow us to complete our comprehensive Asset Register which we expect to complete by November 2025 to inform our budget for 2025/2026.
