The Council were in favour of making the proposed representations with the following amendments to representation 13352 (St John's College):

- The previous designation of Girton as a rural growth area was to take account of the availability within the village envelope and outside the greenbelt of land for approximately 400 houses. This land is now being developed.
- The proposal would impact adversely on the rural views from the Churchyard, Recreation Ground and Girton Wood.

#### 06/54. Allocation of £10,000 to the Recreation Ground Account Head

### 06/55. Meeting of the Budget Committee

Cllr Hiley proposed amending the proposal to the following: that the Budget Committee meet urgently to clarify the budget of 06/07 and come back to Council with recommendations of procedures to monitor financial performance. Sec Cllr Meek, carried *nem con*.

#### 06/56. Remembrance Day and Wreath Donation

- a) The Council agreed to take on the organisation of the Sunday memorial ceremony and donation of wreaths from 2007 which would principally organised by the Clerk. Cllr de Lacey prop, sec J Ford-Smith, carried *nem con*.
- b) A donation of £30 to this years' ceremony was approved. Prop Cllr Godby, sec Cllr Meek, carried *nem con*.
