#### 08/65 Apologies for absence

Apologies had been received from Cllr Hiley, Cllr Bygott, and the Clerk who arrived at item 08/76.

#### 08/66 To elect a chairman

Cllr Godby prop Cllr de Lacey, sec Cllr Gordon, unanimous.

#### 08/67 To elect vice-chairmen

The Chairman prop Cllrs Clift and Ford-Smith sec Cllr Gordon, Cllr Godby prop Cllrs Clift and Taylor, sec Cllr Bullman. Following a hung vote the chairman exercised his casting vote for Cllrs Clift and Ford-Smith.

#### 08/68 Members' declarations of interests

None declared.

#### 08/69 Open Session for Public

Cllr de Lacey prop to suspend Standing Orders, sec Cllr Martin, carried unanimously.

- 1. Members of the Public. No-one wished to speak.
- 2. Police report. Cllr de Lacey read out a police report. Cllr Godby said she was disappointed that none of the crimes mentioned in the report had been previously reported to the parish council. The Clerk to request earlier notification.

- 3. District Councillors' reports. No report received from Cllr Bygott. Cllr de Lacey notified the committee that he had attended the Joint Development Control Committee: Cambridge Fringes meeting which had assessed the two NIAB applications for 187 houses and the new NIAB buildings but that he had been unable to vote until elected to the Committee. He reported that Whitehouse Lane was confirmed as the access to the site. Cllr Gordon asked what is to happen to the original buildings. Cllr de Lacey explained that the new houses are to be built behind the main frontage.
- 4. County Councillor's report. Cllr Reynolds expressed his concern about the site density and filling in behind NIAB. Cllr de Lacey noted that NIAB reserve land in Girton may be required because of delays at Northstowe and Cambridge. Cllr Reynolds said this was a national situation. Liquidity had affected East Anglia and contractors are not taking on extra sites. Cllr Martin asked whether Cambridge might drop out of the congestion charge proposals. Cllr Reynolds replied that lots of correspondence has been absorbed and needs to be discussed with Government. Cllr Martin commented that the reaction against had been made by the general public.
- 5. Girton Town Charity. No report received.
- 6. Youth Works. No report received.
- 7. Footpaths and Rights of Way. Cllr Starling reported two complaints regarding the condition of the footpath from the 10 Acre Field to the Histon Wood. He had passed the complaints on to Peter Duthie who said he would look for additional monies in the coming year to improve the condition.
