Minutes of the Meeting of Girton Parish Council held on Wednesday 18th December, 2013

at St Vincent's Close Community Centre, Girton, at 7.30 p.m.

- **13/138 Welcome from the Chairman** The Chairman welcomed everyone to the meeting especially County Councillor John Reynolds and District Councillor Tom Bygott.
- **13/139 Apologies and reasons for absencen** Apologies for absence from Cllr Hiley and PCSO Mani, and the Chairman accepted their reasons for absence.
- 13/140 Members' declarations of interest for items on the agenda. None.
- 13/141 Public Participation session on agenda items & matters of mutual interest:.
 - 1. Members of the Public. There were no members of the public present at the meeting.
 - 2. County Councillor's Report (*Appendix A*). Cllr Reynolds reported that there are ongoing issues with street lighting replacement and he has been building up a profile of emails from parishioners and officers over the past 2-3 months. Cllr Reynolds has met with the Leader of South Cambridgeshire District Council to discuss lighting problems in Girton and a Senior Executive Director of Balfour Beatty will visit Cambridgeshire to go through a long list of issues. All lights have to remain in the original village e.g. can't be moved from Bar Hill to Girton. Councillors raised concerns regarding trees obstructing street lights and whether Balfour Beatty would be trimming these back in a satisfactory way, and also whether the County Council or Balfour Beatty would be reimbursing the village for the poor service received. Cllr Clift agreed to draft a letter to Balfour Beatty.
 - 3. District Councillors' Reports (*Appendix B*). Cllr Bygott spoke about the pilot scheme for the private company South Cambs Ltd to build 40 new homes in the next two years. Although welcoming the news that unemployment figures have reduced, Cllr Bygott noted the increase in homelessness nationally. SCDC want to halve the current bill to house people in B&B accommodation. Central government funding figures have been released with Cambridgeshire funding cut by 24% (£874,000) part of which could be offset by New Homes Bonus.

Cllr Bygott mentioned the Community Pride Awards, nominations for which close on 24th January 2014.

Cllr de Lacey gave an update on his report, to say that the JDCC has met and approved the Chesterton Station application. The Section 106 for the Darwin Green project has been agreed and signed. Plans for Darwin Green 2 & 3 will wait until the Local Plan is published.

4. Police Report (*Appendix C*) The Chairman read out an additional police report from PCSO Mani, received earlier that day. Concerns were raised over burglaries in the village. The Clerk agreed to forward any questions to PCSO Mani.

Cllrs Reynolds and Bygott left the meeting at this point.

13/144 Business items requiring a decision, or consideration by the Council

1.. To approve the 2014-15 budget and precept (Appendix D)

As the Council has yet to receive confirmation of the Band D household figures, Cllr de Lacey proposed that councillors have a general discussion regarding the budget at this meeting and then decide the budget in January 2014, seconded by Cllr Westley. The Finance Committee have suggested an overall increase of 2.5%. There are fewer Band D households in the village than last year. Cllr M Taylor proposed that the item be deferred until the January parish council meeting, seconded by Cllr Williams, agreed with 5 abstentions.

- 2. To approve an Equality Policy for Girton Parish Council (*Appendix E*) Proposed by Cllr de Lacey, seconded by Cllr Cockley. Concerns were expressed regarding the paragraph on accessibility to the Parish Office. Cllr Williams proposed an amendment, to remove the word 'progression' from the paragraph about employees, agreed by Cllr de Lacey. With this amendment, the policy was approved unanimously.
- 3. To approve a Conflict of Interest Policy for Girton Parish Council (*Appendix F*) Proposed by Cllr de Lacey, seconded by Cllr Garner and approved with one abstention. 4. To receive a report from the Chairman of the Bowling Green Committee, and on the basis of that to agree the following proposals(*Appendix G*):
- (a) To rent the Bowling Green to Girton Community Bowling Club for a fee of £1 for the calendar year 2014. Proposed by Cllr Westley, seconded by Cllr de Lacey. : The Bowls Club will officially be formed in January 2014, and it is suggested that the club be given time to find its feet. The main costs will be maintenance, with the Girton Town Charity agreeing that this is part of the set-up costs. Approved unanimously.
- (b) To permit individual players to play under the aegis of the Club for a fee to be determined by the Sport and Recreation Committee and paid to the Council. Proposed by Cllr Westley, seconded by Cllr de Lacey. The Bowls Green is a village facility, and the Club would be happy to supervise this and to use their equipment. Approved unanimously.
- (c) To pay for the one-year maintenance contract agreed with Two County. Proposed by Cllr Westley, seconded by Cllr de Lacey. The first couple of years' maintenance are critical in getting the bowls green established. Two County have worked very well and to a high standard. Approved unanimously. Cllr M Taylor left the meeting at this point.
- 5. To approve the submission of an application to Amey Cespa for a grant for the playground/Pavilion (see correspondence item 13/146.7). Proposed by Cllr de Lacey, seconded by Cllr Gordon. The Council would like to make a grant application for the car park works, but if this is not acceptable would like to
